COMMUNICATION TO OWNERS AND RESIDENTS: 22 OCTOBER 2018

The Committee has been investigating options to get a better and more reliable internet service to the Nautilus estate. Presently we have a provider that provides a service from Vleesbay via an antenna, or with a Vodacom, or other provider's sim card.

A company by the name of VTS has approached us with a solution that might interest the Nautilus owners. Presently they are supplying one of the Nautilus owners with a link via Danabay. This link works with an antenna attached to the house and line of site. However, to have a more cost effective and stable internet service at Nautilus they would have to erect a mast on the Nautilus site. The following information regarding the construction of the mast was provided by VTS:



"The concrete base will be +- 1.5 x 1.5m. This will be underground. The tower itself is a 3 leg tower (400x400x400mm) and the height will be between 6 and 8 meters high depending on visibility to the houses. We will also put in a box at the bottom of the tower to house the equipment. We can paint this if needed."

VTS proposed a site is near the sewer plant as this would give them the most height advantage in order to have line of sight to all the houses.

They would then supply Nautilus residence with several options depending on your needs and usage. Also, they are willing to accommodate non-permanent residents that only require wi-fi for periods of time on a
